1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in Daily news Issue no. 12,304 dated 12th December, 2018.
2. The Government of Tanzania has set aside funds for the operation of the Gas Company (Tanzania) Limited during the financial year 2018/19. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the supply and installation of backup sever and integration with existing SCADA system for Madimba GPP and Gas Pipeline.
3. GASCO now invites sealed tenders from eligible Suppliers of supply and installation of backup sever and integration with existing SCADA system for Madimba GPP and Gas Pipeline.
4. Tendering will be conducted through the National Competitive Bidding procedures specified in the Public Procurement Regulations, 2013 – Government Notice No. 446 as amended in 2016, and is open to all Tenderers as defined in the Regulations.

A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tshs. 100,000** (Tanzania shillings One Hundred Thousand Only). 7. All tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.

All tenders in one original plus two copies, properly filled in, and enclosed in plain envelopes marked **“SUPPLY AND INSTALLATION OF BACKUP SEVER AND INTEGRATION WITH EXISTING SCADA SYSTEM FOR MADIMBA GPP AND GAS PIPELINE, NOT TO BE OPENED BEFORE 15th MARCH, 2019 11:00HRS”** must be delivered to the **Gas Company (Tanzania) Limited, Plot No.1 Block D, Kibaga Street, Kinyerezi Gas Receiving Station, Dar-es-Salaam, Tanzania, Room number 04 on the 1st floor** at or before **Friday 15th March 2019, 11:00hours**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers’ representatives who choose to attend in the opening at the Kinyerezi Board Room at 1st floor.
9. Late Tenders, Portion of Tenders, Electronic Tenders, Tenders not received, Tenders not opened and not read out in public at the tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
