

3 calls for tenders for the development of solar and wind projects over 2023-2025 with a total capacity of up to 1.7 GW

- **Tunisia issued the following 3 calls for tenders:**

1 - Call for Tenders #01-2022 for Photovoltaic Power Projects

The Ministry of Industry, Mines and Energy (the Ministry) intends to select eight (8) power generation projects from photovoltaic solar energy of 100 Mega Watts (MW) each in four (4) rounds over 2023-2025 as the following:

Round #1: 2 Photovoltaic Power Plants of 100 MW each with a submission deadline on Thursday, June 15, 2023 at 12:00 p.m. Tunis time.

Round #2: 2 Photovoltaic Power Plants of 100 MW each with a submission deadline in March 2024.

Round #3: 2 Photovoltaic Power Plants of 100 MW each with a submission deadline in November 2024.

Round #4: 2 Photovoltaic Power Plants of 100 MW each with a submission deadline in September 2025.

The Ministry is inviting interested bidders to submit offers for the implementation of solar photovoltaic concession projects on sites suggested by bidders. In order to receive tender documents and additional information by email, interested bidders must register on inscription AO 01-2022.

2- Call for Tenders #02-2022 for Wind Power Projects

The Ministry of Industry, Mines and Energy (the Ministry) intends to select eight (8) power generation projects from wind energy of 75 Mega Watts (MW) each in four (4) rounds over 2023-2025 as the following:

Round #1: 2 Wind Power Plants of 75 MW each with a submission deadline on Thursday, September 14, 2023 at 12:00 p.m. Tunis time.

Round #2: 2 Wind Power Plants of 75 MW each with a submission deadline in May 2024.

Round #3: 2 Wind Power Plants of 75 MW each with a submission deadline in February 2025.

Round #4: 2 Wind Power Plants of 75 MW each with a submission deadline in November 2025.

The Ministry is inviting interested bidders to submit offers for the implementation of wind power concession projects on sites suggested by bidders. In order to receive tender documents and additional information by email, interested bidders must register on inscription AO 02-2022.

3- Call for Tenders #03-2022 for two (2) Photovoltaic Power Projects in Hecha and Khobna.

The Ministry of Industry, Mines and Energy (the Ministry) is inviting bidders to submit offers for the implementation of two (2) concessions of solar photovoltaic power projects:

The first concession project will be on a 300 Hectares (741 Acres) land in Hecha in the governorate of Gabes.

The second concession project will be on a 270 Hectares (667 Acres) land in Khobna in the governorate of Sidi Bouzid.

The deadline to submit offers is Thursday May 18, 2023 at 12:00 p.m. Tunis time.
